

MESSAGE FROM THE 2019 PRESIDENT JORDAN LESTER

On behalf of the Board of Trustees, I am proud to share the Thunder Bay Community Foundation's Annual Report for 2019.

Overall, 2019 was an excellent year for the Foundation. First and foremost, we welcomed our new Executive Director Alexandra Calderon. Alexandra is dynamic, energetic, and passionate about the work the Foundation does in the community. The Board is very optimistic about the future of the Foundation in her very capable hands.

In the fall, the Board created a strategic plan for the Foundation both for the short and long term. The strategic plan focuses on five key components: growing our donor engagement, growing our granting capacity, growing our community engagement, strengthening our governance, and creating a gold standard for organizational excellence.

As of December 31, 2019, the Foundation's portfolio was \$13.65 million, which is roughly a \$2.5 million increase from the 2018 year end. This incredible growth can be attributed to several factors. Firstly, in the spring of 2019, the Foundation received a donation of \$1.26 million, which is one of the single largest acts of philanthropy our community has ever seen. Secondly, thanks to a successful year in the market, we enjoyed a remarkable 16.5% return on investment. Thirdly, we brought on several new funds, including the John Rafferty Memorial Fund and the Danny Clara Legacy Fund.



2019 was also a very strong year for our community building efforts. We awarded 34 scholarships and bursaries to graduating local high school students, totaling over \$100,000. We also awarded 37 grants to organizations throughout the district, totaling over \$200,000.

Throughout the year, we said goodbye to trustees Lesley Bell, George Badanai, Paul Jasiura, Reily Madigan and Mike Larizza. They all served the Foundation dutifully and their contributions are too many to list. With their departures we added several new trustees: Brian Whitfield, Julie Cleghorn, Catherine Walsh and Mike Belliveau.

Special thanks are in order for Paul Jasiura and Arlene Capricci who opened up their beautiful home for our alumni reception in October. As well, many thanks go out to the volunteers who assisted with the Student Awards Marking Committee and our Grants Marking Committee. These are both big endeavours and we are forever indebted for their assistance.

Finally, I would like to thank all of our donors and fund holders. Without you, there would be no Foundation. Your continued support and generosity is what gives our organization the ability to help build our community.





ANDREW JOHNSON

INSTITUTIONAL PORTFOLIO MANAGER

Despite the exceptional volatility so far in 2020, we've attempted to stay balanced and diversified, both with respect to our portfolios and our decision-making. We're attempting to be in two spots at the same time: making decisions so that portfolios are relatively well-positioned whether developments turn positive or more negative. Our investment criteria haven't shifted. We've stuck to our long-term philosophy, emphasizing companies that have strong business models and strong balance sheets—ideally both!



In general, these companies tend to generate more recurring revenue, are less discretionary in nature, are typically highly cash generative, and, when led by shrewd managers, should be in a position to take market share in a weakened competitive environment.

As a refresher, our investment philosophy leads us to build portfolios of genuinely wealth-creating businesses. We believe this remains a prudent approach for investors looking to protect and compound capital over long periods of time. That is our way of executing on keeping your investment experience "boring." While the next decade will bring its share of uncertainty, we're unlikely to change our disciplined and time-tested approach.

2019 closed with a risk-on rally in which risky assets globally capped off a remarkable comeback. The shift in investor psychology that began in early 2019 with central banks' recommitment to lower interest rates further improved in Q4 as some of the uncertainty investors had been worried about was removed: negotiations between the U.S. and China appeared to be progressing, the Conservatives' decisive victory in the U.K. gave Brexit clarity, and, closer to home, the results of the Canadian election largely signaled "business as usual."

TBCF's benchmark increased by 14.5% for the 12 months ending December 31, 2019 given the rally seen in markets. TBCF's investment portfolio returned 16.5%, outpacing the benchmark by approximately 2%. The portfolio's overweight position in US and International equities as well as a health weight in Small Cap securities, contributed to the positive relative performance versus the benchmark.

Good Neighbour Fund

In June 2019, the Thunder Bay Community Foundation launched the Thunder Bay Good Neighbour Fund which was created to support evacuees from neighbouring Pikangikum First Nation after forest fires began and left a devastating effect on the community.

The funds raised were designated to St. John Ambulance as per the proposal put forth by the CEO of Independent First Nations Alliance and the Chief of Pikangikum First Nation.

The \$13,000 fund was made possible by donations from Thunder Bay Broom and Chemical Ltd., Uride Thunder Bay, the Toronto Community Foundation, Happy Time Tours and Travel, as well as many individual donations.

The Pilot Fund for Gender Equality

The Thunder Bay Community Foundation was pleased to participate in a Canada-wide initiative by Community Foundations of Canada to support gender-equality. Three local organizations received a combined \$35,000 from the Thunder Bay Community Foundation for projects and organizations that serve women within the city. Elizabeth Fry Society of Northwestern Ontario, Roots to Harvest, and Beendigen were the three local organizations who received funding through the Pilot Fund for Gender Equality.

"This pilot is really centred around core themes of peace, power, and planet that connect the women's movement in Canada and internationally," said Alexandra Calderon, Executive Director at the Thunder Bay Community Foundation. "I believe these are three incredible local programs that are really helping to build a more equitable Thunder Bay." The Pilot Fund for Gender Equality was supported by a collaboration between the Thunder Bay Community Foundation, the Community Foundation of Canada, and the Equality Fund with support from the Government of Canada.
